*Annual Percentage Rate. Promotional rate of 3.99% applies to all balance transfers and cash advances posted to a First Ohio Credit Card from November 1, 2022 to December 31, 2022. The promotional 3.99% rate will be effective until June 30, 2023. After that time, all credit card balances (including purchases, cash advances and balance transfers) will revert to the regular credit card rate.



Need some extra cash this holiday? Take advantage of our **Holiday Skip-A-Pay**. Eligible members will receive a letter in the mail during the middle of October.

To take advantage of this offer, either return the letter you received in person or via mail, along with the \$30 processing fee* per loan skipped, and we will take care of the rest. Put a little extra cash in your pocket this holiday season with First Ohio's Holiday Skip-A-Pay.

*Members are eligible to skip one payment per 12 month period. Members who took advantage of our 2022 Summer Skip-A-Pay program are not eligible. Skip-A-Pay is not available on Credit Card and Home Equity loans. Payment of the \$30 fee will not be applied to principle, interest or other fees, which might be due on your loan. Any additional interest that accrues due to this deferred payment will be due and payable upon maturity. Taking advantage of this offer will extend the maturity date on your original contract. This offer is valid for the November 2022 and December 2022 payment only. Not valid for October 2022 payments. Coupon and fee are due at least 10 days before your payment is due.

Do you need access to your payroll early to purchase that special gift? We can help you with **On Demand** Posting.

If you are receiving direct deposit, and your employer sends your deposit to the credit union before your actual pay day, we can post that deposit early. Here's how it works:

- * Verify your deposit is pending. You can see this in It'sMe247 home banking via our FREE mobile app, by clicking the three dots next to your deposit account and choosing "ACH Transactions". This is also available in the desktop version of It'sMe247 Home Banking or by calling the credit union.
- * Normally, you would need to verify you have money in your account to pay the early posting fee±. For the month of December, we are offering this service FREE of charge, as a gift to our members!
- * Authorize a staff member to post your deposit and we will take care of the rest! It is REALLY that easy! Once the funds are posted, they will be available to use for purchases and/or bills that you need to pay.

± Normal Processing Fee of \$5.00 per deposit posted early. Early deposit authorization must be completed each time you want to post a direct deposit early. Money must be available in your account prior to making the deposit to pay the fee.

2022 Tax Forms

Your 1099-INT Form will be included with your December Statement and not mailed in a separate envelope. Please make sure to look through ALL of the pages in your December Statement. 1098 Forms and 1099-R Forms will be mailed separately, by January 31, 2023. Tax information will also be available in It'sMe247 online banking.
